Referring to item A, Mr. Smith pointed out that claims are up by 1,000, representing \$1.6 million higher, so the claims are in fact coming in at a greater rate. He expected the dollars to be drawn down by the end of the year.

### **NEW BUSINESS**

## A. UPDATE: Health Policy and Planning Commission

HPPC Chair Larry Martinez stated a Healthcare Reform Committee meeting will be held November 11<sup>th</sup> regarding the second half of the report on federal healthcare reform and the impact of the state budget. The latter will have a more immediate effect on the providers. There have been significant reductions in funding for maternal and child healthcare, family planning, and school and adolescent health.

He reported that Barbara Nail-Chiwetalu presented a training on health literacy to the HPPC emphasizing what people need to know about their own health. It is predicted that within a few years one third of the American public will be diabetic, which will be a drain on health resources.

Mr. Martinez said Kay Duckworth, an alternative medicine provider and new member of the HPPC will be making a presentation at the November 5<sup>th</sup> meeting. Santa Fe has one of the highest penetrations of complementary medicine in the country.

Commissioner Montoya asked about the cuts to rural healthcare, and Mr. Martinez explained they come from reductions at the State Department of Health. Secretary Alfredo Vigil said there was no "wiggle room" in facilities providing 24-hour care and thus the other programs had to take cuts. Further cuts are coming.

Alex Valdez said Medicaid also took about a \$7.5 million hit for CHRISTUS St. Vincent, with another \$6.7 million cut anticipated. Statewide there will be an \$80 million impact.

Mr. Martinez said the matching ratio will be 69-31 as opposed to the current 80-20 from the stimulus package.

## B. CHRISTUS St. Vincent Regional Medical Center

Speaking to the subject of integrative medicine Mr. Valdez stated Dr. Catrona Lodog will be running an integrative medicine program in the Sports Medicine program. She has worked with Dr. Weil in Arizona.

Mr. Valdez distributed budget material for the coming year. [Exhibit 1] He said he is comfortable with the role CHRISTUS St. Vincent is playing with the CARE Connection and Sobering Center.

Other issued discussed by Mr. Valdez:

- The contract for jail medical director has been a complex process but he hoped that it would be completed soon.
- The County needs to terminate the jail pharmaceutical contract with Diamond Drugs, after which the hospital will take up the contract.
- Paratransit will be coming before the City Council tomorrow. Subsequent to that
  he will ask the City to accommodate nearby County residents and CHRISTUS St.
  Vincent will compensate them.
- The hospital will no longer be billing the County for inmate care; they will work
  with the County to get the claims processed. He anticipated they would be
  working with a difficult population and need demographic information from the
  County.

Referring to the estimate of \$500,000, Mr. Smith said he just received a bill for \$1.3 million. Mr. Valdez said they would figure out how to handle that.

Referring to Community Health, Mr. Valdez stated the uncompensated care mentioned includes both uncompensated and undercompensated care. Among the goals are preventing unnecessary hospitalizations and re-admissions. Behavior health has a profound impact on the community and the 25 most frequent users of emergency services have been identified and strategies are being developed to intervene and manage the healthcare or these people. The emphasis is on harm reduction.

Other initiatives include chronic disease management, collaboration with Women's Health Services, training staff on domestic violence issues and early childhood programs.

Mr. Valdez distributed stickers given to providers that recognize the role of Santa Fe County taxpayers, along with other materials of interest. [Exhibit 2]

Commissioner Stefanics asked if Dr. Lodog was on the website. Mr. Valdez said he would check. In response to another question from Commissioner Stefanics, he said Kathy Etre would be the contact person for paratransit.

Amplifying on the 25 most frequent ER users, Ms. Etre stated they are using case management and assertive community treatment (ACT). It is too early to determine the long-range impact. The new domestic violence coordinator is Kristin Carmichael. Commissioner Stefanics encouraged keeping track of repeat offenders.

Regarding the jail contract, Commissioner Stefanics asked if that couldn't be pulled back from the hospital due to liability issues.

Commissioner Montoya asked about the vacancies in the CARE Connection staff. Ms. Etre said they are being covered with temporary staff and hires are being made.

Commissioner Stefanics asked if the hospital has anyone that could help set up electronic medical records at the jail. Mr. Valdez said he would look into it.
