1. The Santa Fe County Commission met as the Canvassing Board at approximately 2:00 p.m. on November 12, 2019, in the Santa Fe County Administration Complex, 100 Catron Street, Santa Fe, New Mexico.

2. **Roll Call**

3. **Motion to Convene as County Canvassing Board, Pursuant to Section 1-13-1, NMSA 1978**

CHAIR HAMILTON: I would entertain a motion to convene this Canvassing Board?

COMMISSIONER HANSEN: Madam Chair.

CHAIR HAMILTON: Yes, Commissioner Hansen.

COMMISSIONER HANSEN: I move to convene the Canvassing Board.

CHAIR HAMILTON: Can I have a second?

COMMISSIONER MORENO: Second.

The motion passed by unanimous [4-0] voice vote. [Commissioner Garcia was not present for this action and joined the meeting directly thereafter.]

4. **Motion for Approval of November 5, 2019 Regular Local Election Canvass Pursuant to Section 1-13-4, NMSA 1978**

CHAIR HAMILTON: We are convened as the Canvassing Board. Geraldine, do you have a report?

GERALDINE SALAZAR (County Clerk): Yes. I would like Steve and

CHAIR HAMILTON: Thank you.

CLERK SALAZAR: They had to work Saturday and yesterday we were at the warehouse until 6:00.

STEVE FRESQUEZ (Bureau of Elections): Good afternoon, members of the Commission. Nice room. Really beautiful.

We're here to present for your approval the unofficial results of the 2019 regular local election which we finalized yesterday. So these results will be sent to the Secretary of State's Office and they will convene on the 26th of November to make these results official.

We had 17,207 voters turned out for this election to vote on multiple types of races from Santa Fe City Council to school board elections to some bond questions as well. We had some multi-county races – Moriarty School District, Espanola Valley School District.

These, like I say, are unofficial. They will be posted on our website after they are approved and I stand for questions.

CHAIR HAMILTON: Thank you. Commissioners, do you have any questions?

COMMISSIONER HANSEN: I do.

CHAIR HAMILTON: Commissioner Hansen.

COMMISSIONER HANSEN: Thank you, Madam Chair. So I just see that some of the numbers like 2,000, is the municipal judges citywide or countrywide?

MR. FRESQUEZ: It was citywide.

COMMISSIONER HANSEN: Okay.

MR. FRESQUEZ: We had the four City Council districts and then the municipal judge.

COMMISSIONER HANSEN: Because it's the only one that had really a low number.

CLERK SALAZAR: Each district within the city is their own district and the judge is at-large citywide, within the county. Remember a whole portion of that city is the Santa Fe County.

COMMISSIONER HANSEN: Right. Okay. That was it.

CHAIR HAMILTON: Thank you. Any other questions?

COMMISSIONER HANSEN: Madam Chair.

CHAIR HAMILTON: Commissioner Hansen.

COMMISSIONER HANSEN: I make a motion to approve the November 5th regular local election canvass pursuant to Section 1-13-13A NMSA 1978.

COMMISSIONER MORENO: I second the motion.

CHAIR HAMILTON: Thank you.

COMMISSIONER GARCIA: Madam Chair, just for discussion, I actually would like to recuse myself from this because I am on the ballot, so I'd like to recuse myself.

CHAIR HAMILTON: Thank you. Thank you very much.

COMMISSIONER HANSEN: Thank you.

CHAIR HAMILTON: So we have a motion and a second. Is there any

further discussion?

The motion passed by unanimous [4-0] voice vote with Commissioner Garcia having recused himself.

MR. FRESQUEZ: I don't know if you'd like to sign these certification sheets after the meeting, but they do have to be signed today.

CHAIR HAMILTON: If you pass them around we'll sign them.

5. Adjournment

Upon motion by Commissioner Hansen and second by Commissioner Roybal, and with no further business to come before this body, Chair Hamilton declared this meeting adjourned at 2:07 p.m.
