SANTA FE COUNTY INVESTMENT COMMITTEE MEETING MINUTES DECEMBER 19, 2011

Committee Members in Attendance:

- I. Meeting called to order:
 - Roll call.
 - A motion to approve the November 18, 2011 minutes was made by Teresa Martinez and seconded by Stephan Ross.
 - A motion to approve the December 19, 2011 Agenda was made by Stephan Ross and seconded by Teresa Martinez.

II. Current Agenda Items:

1. The first item on the agenda was investment activity since the last Investment Committee Meeting on November 18, 2011. For further details please refer to the portfolio.

Starting on page 4 of the portfolio all the items highlighted in yellow are the new investments that we have made with Wells Fargo in the amount of \$1,750,000.00

On page 6 the highlighted ones in yellow are Government agencies with the interest rates and projected maturities we are getting on those investments. The call protection on these investments runs from three months to a year.

- 2. Property Tax Collection and Distributions:
 - a. The \$40, 865,363.51 in distributions collected for November 2011 property taxes will be made on December 20, 2011. The County's share for November 2011 collections is \$15,317,094.87. The maintenance report shows we have collected \$40,107,985.06 through November 30, 2011; through the first month of 2011 tax collections. The tax collection rate through November 30, 2011 is 26.42%.
 - b. Year to date collection rate November 30, 2011 over November 2010 shows we are up 10.1%; and in dollars we are \$3,695,020.42 over the last year's collections. We are 26.42% collected for December.
 - c. We transferred \$45 million from LANB to the Charles Schwab accounts in the US Treasury Money market at the request of the bank because they had too much capitol and needed to show a reduction of capitol due to the end of the quarter. They have agreed to pay the same amount of yield .5 % while our funds are at Charles Schwab.

- 3. Status of Accounts at the LGIP:
 - a. The State Treasurer's LGIP balance for the County as of November 30, 2011 was \$639.25 the interest we gained was 20 cents. We no longer have any substantial amounts invested in the State Treasurer's LGIP therefore there's no need for their portfolio reports.

4. Morgan Keegan Chart:

- a. On page 9 Treasury yield curve is at -0.01% we would not make any money for parking it there. One year ago Treasuries paid .2699 as you can see yields are really dire.
