3 **A RESOLUTION**  
4 **PROPOSING THE ADOPTION OF AN ORDINANCE**  
5 **IMPOSING A QUARTER CENT GROSS RECEIPTS EXCISE TAX**  
6 **FOR COUNTY FIRE PROTECTION IN SANTA FE COUNTY**

9 **WHEREAS**, the Santa Fe County Board of County Commissioners (hereinafter  
10 “Board”) proposes the adoption of an ordinance imposing an excise tax of one-fourth  
11 of one percent (0.25%) of gross receipts in Santa Fe County, New Mexico, pursuant  
12 to the “County Fire Protection Excise Tax Act”, and

13  
14 **WHEREAS**, the Board is authorized by state statute (7-20A-1, NMSA 1978 et  
15 seq.) to impose an excise tax equal to one-fourth of one percent (0.25%) of gross  
16 receipts in Santa Fe County, New Mexico, for the purpose of financing the  
17 operational, capital outlay and ambulance expenses of the Santa Fe County Fire  
18 Department; and

20 **WHEREAS**, the proposed ordinance must be approved by referendum of the  
21 voters of Santa Fe County pursuant to Section 7-20A-1, NMSA 1978, et seq., and

23 **WHEREAS**, the proposed effective date of said ordinance is July 1, 2010, and,

25 **WHEREAS**, the Board authorizes the publication of the proposed ordinance and  
26 notice of public hearing where the Board will consider the adoption of such an  
27 ordinance. Said publication shall be published one time in a newspaper of general

1 circulation within Santa Fe County two weeks prior to the meeting of the Board at  
2 which time said ordinance would be considered.

3  
4 **NOW, THEREFORE BE IT RESOLVED** by the Santa Fe Board of County  
5 Commissioners that notice of public hearing be given of the Board's intent to  
6 consider said ordinance. The proposed ordinance is attached hereto and incorporated  
7 herein as Exhibit A.

8  
9 **MOREOVER**, it is ordered that a copy of the proposed ordinance be filed in the  
10 Office of the County Clerk for review by interested persons beginning with the date  
11 of publication and continuing to date of consideration by this Board.
