The Utilities Department respectfully requests consideration of a Resolution Amending Resolution 2011-79 to Correct Errors to Exhibit A. This resolution does not propose any changes to the fees approved by the Board of County Commissioners on May 31, 2011 but is intended to provide clarifying language.

BACKGROUND

Resolution 2011-79 was adopted with minor language deficiencies, which has caused some confusion for our utility customers. To clarify language in the water fee schedules this resolution will amend Exhibit A to add the words "Fee per 1,000 Gallons" to rate schedules 1 and 2 of the previously approved resolution.
