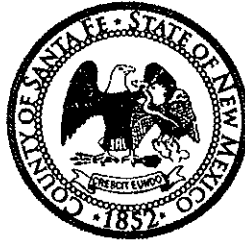

A RESOLUTION SUPPORTING THE RODEO DE SANTA FE CONTRIBUTIONS TO SANTA FE COUNTY

WHEREAS, Rodeo de Santa Fe (the "Rodeo") began in 1949 when Gene Petchesky and Austin "Slim" Green had a dream and the determination to organize a rodeo in Santa Fe;

WHEREAS, this dream exceeded their expectations and became what is today, one of the top 100 rodeos in the nation sanctioned by the Professional Rodeo Cowboys' Association (PRCA);

WHEREAS, over 600 PRCA Cowboys & Women's Professional Rodeo Associations (WPRA) from all over the United States compete in the annual event;

WHEREAS, the Rodeo is a fun-filled family event for residents of Santa Fe and northern New Mexico as well as tourists visiting our community;

WHEREAS, the Rodeo boards horses during fire, disaster, and heavy storms;

WHEREAS, the Rodeo has served as an evacuation center for regional and statewide needs during state of emergencies for livestock, etc.

WHEREAS, the Rodeo grounds provide affordable stabling and layover for equestrian and agricultural livestock, interstate and intrastate transport teams;

WHEREAS, the Rodeo has a national reputation for excellence;

WHEREAS, the Rodeo and the Santa Fe County Fair Board share a common mission to preserve and promote rural and agricultural traditions and culture of New Mexico;

WHEREAS, the Rodeo has been a strong supporter of the Santa Fe County Fair through networking and the sharing of facilities and resources; and

WHEREAS, the Rodeo and its annual events have built an impeccable reputation as a charitable and responsible member of the Santa Fe community and region.

NOW, THEREFORE, THE BOARD OF COUNTY COMMISSIONERS HEREBY RESOLVES that the County of Santa Fe recognizes the benefits of the Rodeo de Santa Fe to the County and the County Fairgrounds property.

Re: Resolution Accepting the Santa Fe County Housing Authority Roads for County Maintenance

ISSUE:

The Santa Fe County Housing Authority requests approval of a Resolution accepting the County Housing Authority roads for County maintenance.

BACKGROUND:

The Santa Fe County Housing Authority manages public housing units located at three scattered housing neighborhoods within Santa Fe County. The roads located in these neighborhoods are not currently maintained by the County. The Cooperation Agreement between the County and the U.S. Department of Housing and Urban Development signed in 1972, states that Santa Fe County will accept the dedication of all interior streets within the area of the public housing neighborhoods. To date, these streets have not formally been added to the County's inventory for maintenance.

The Housing Authority is requesting that the public housing neighborhood roads located in ValleVista and Santa Cruz be accepted for County maintenance.

In November, 2009, Camino de Jacobo was annexed into the City of Santa Fe. This public housing neighborhood road will be maintained by the City of Santa Fe.

RECOMMENDATION:

The Santa Fe County Housing Authority requests that the Board of County Commissioners approves the Resolution accepting the Santa Fe County Housing Authority roads for County maintenance.

**A RESOLUTION ACCEPTING THE SANTA FE COUNTY HOUSING
AUTHORITY ROADS FOR COUNTY MAINTENANCE**

WHEREAS, the Santa Fe County Housing Authority was created by the Santa Fe County Board of Commissioners on November 22, 1971;

WHEREAS, the Santa Fe County Housing Authority operates as the Housing Services Division of the Community Services Department of Santa Fe County;

WHEREAS, the Santa Fe County Housing Authority manages 200 public housing units located at three different area neighborhoods within Santa Fe County;

WHEREAS, the roads located within the three different Santa Fe County Housing Authority public housing neighborhoods are not currently maintained by Santa Fe County but are in the unincorporated areas of the County;

WHEREAS, the Cooperation Agreement signed by Santa Fe County and the federal Department of Housing and Urban Development in 1972, states that Santa Fe County will accept the dedication of all interior streets, roads, alleys, and adjacent sidewalks within the area of the public housing neighborhoods;

WHEREAS, the Cooperation Agreement further states that Santa Fe County will “grade, improve, pave, and provide sidewalks for all streets bounding such project or necessary to provide adequate access thereto”;

WHEREAS, the Santa Fe County Housing Authority agrees to maintain the sidewalks, lighting, speed humps, and vegetation and will be responsible for snow removal in the Santa Fe County public housing neighborhoods;

WHEREAS, the Santa Fe County Public Works Department will be responsible for installation and maintenance of traffic signs, pot-hole repair, and curb to curb maintenance of the streets located in the Santa Fe County public housing neighborhoods; and

WHEREAS, the Santa Fe County Public Works Department has conducted an evaluation of the Housing Authority roads and has determined that crack sealing is needed on Camino de Roberto and Camino de Quintana which the Housing Authority has agreed to repair.

NOW, THEREFORE, BE IT RESOLVED that the Santa Fe County Board of County Commissioners accepts the following Santa Fe County Housing Authority public housing neighborhood roads for maintenance:

Sierra Place North – a paved 32 foot driving surface road, from the intersection of Valle Vista Boulevard to the dead end, a distance of 0.2 miles.

Val Verde Drive – a paved 30 foot driving surface road, from the intersection of Sierra Place North to the intersection of San Mateo Way North, a distance of 0.1 miles.

San Mateo Way North – a paved 32 foot driving surface road, from the intersection of Valle Vista Boulevard to the dead end, a distance of 0.2 miles.

Las Lomas Drive – a paved 30 foot driving surface road, from the intersection of Sierra Place North to the intersection of San Mateo Way North, a distance of 0.1 miles.

Tusa Drive - a paved 30 foot driving surface road, from the intersection of Sierra Place North to the end of San Mateo Way North, a distance of 0.1 miles.

Camino de Quintana- a paved 37 foot driving surface road, from the intersection of South McCurdy Road to the dead end, a distance of 0.4 miles.

Camino de Roberto – a paved 30 foot driving surface road, from the intersection of Camino de Quintana to the dead end, a distance of 0.1 miles.

BE IT FURTHER RESOLVED that said roadways shall be added to the certified listing of County maintained roads filed with the New Mexico Department of Transportation.
