A RESOLUTION ESTABLISHING GUIDELINES FOR A CAPITAL IMPROVEMENT AND MAINTENANCE FUND FOR THE WILDLIFE, MOUNTAINS, TRAILS AND HISTORIC PLACES PROGRAM

WHEREAS, voters in Santa Fe County approved a General Obligation Bond establishing funding for the "Wildlife, Mountains, Trails and Historic Places Program," ("Program") on November 3, 1998; and

WHEREAS, the County is acquiring lands for the Program to preserve historic and natural areas, mountains and foothills, arroyos and river parkways, sacred sites, trails and high desert habitats, and to establish neighborhood parks and playfields; and

WHEREAS, the County passed Resolution No. 2000-57 requiring landowners to donate five percent (5%) of the purchase price to a Capital Improvement and Maintenance Fund for properties acquired through the Program; and

WHEREAS, a Capital Improvement and Maintenance special revenue fund has been established and has received donations as a result of property acquisitions.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners (BCC) of Santa Fe County that:

The Capital Improvement and Maintenance Special Revenue Fund ("Fund") for the Wildlife, Mountains, Trails and Historic Places Program shall be governed by the following guidelines:

- 1. The Land Use Administrator or the Deputy Land Use Administrator, and the County Manager or the Finance Director, shall have the signatory authority to approve expenditures from this Fund. Two signatures shall be required for all such expenditures.
- 2. The Land Use Department, with advice from a Technical Advisory Team, shall establish an annual budget for the Fund as part of the annual budget cycle to be approved by the BCC.
- 3. The BCC shall approve budget adjustments to the Fund.
- 4. The Fund shall be used only for the purpose of improving and maintaining properties acquired through the Program.

5. The Fund shall be budgeted over a period of no less than two years, and appropriations shall be made over the course of the budget period.
