**WHEREAS**, absent the dedication and commitment of employees to their respective Department's mission, goals, and objectives, Santa Fe County could not render the services necessary to meet residents needs;

**WHEREAS**, much of the work of a Santa Fe County employee requires exacting skills and demanding tasks, often times imposing multi-responsibilities on employees;

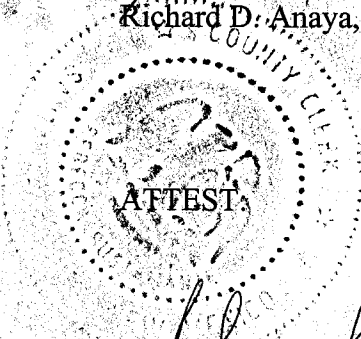
**WHEREAS**, the Board of County Commissioners recognizes the contribution and commitment of the County Manager and County employees;

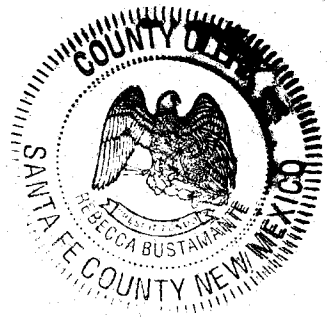
