A JOINT CITY/COUNTY RESOLUTION

**SUPPORTING STATE LEGISLATIVE ACTION RELATED TO REVISION OF
THE DEVELOPMENT FEES ACT TO INCLUDE SCHOOLS AS AN ELIGIBLE
FACILITY.**

WHEREAS, the City and the County of Santa Fe in association with the Santa Fe School District (the "School District") anticipate the need for additional school facilities based on future growth; and

WHEREAS, the City and the County of Santa Fe acknowledge the value and need for quality educational opportunities for Santa Fe youth; and

WHEREAS, the City of Santa Fe General Plan and the Santa Fe County Growth Management Plan (collectively the "General Plans") call for the establishment of cooperative relationships between the City, the County and the School District to identify ways in which all entities can meet the expanding needs of community growth and quality education; and

WHEREAS, the General Plans cite the role of schools as pivotal in establishing

1 relationships within the community among schools, residences, transit, and trail systems;


3 WHEREAS, the School District has adopted Resolution 101700 to pursue
4 legislative revision to the Development Fees Act that would allow schools to be
5 considered an eligible facility; and 1858934



6 WHEREAS, the City and the County of Santa Fe recognize the need and desire
7 for alternative funding sources for capital outlays.

8 NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY
9 OF THE CITY OF SANTA FE AND BY THE BOARD OF COUNTY
10 COMMISSIONERS OF SANTA FE COUNTY that these Governing Bodies will
11 actively support State legislation to amend the Development Fees Act to include schools
12 as an eligible facility within the Act.

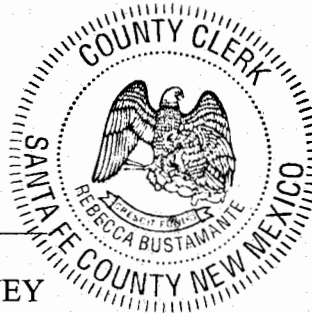
