10 A JOINT CITY/COUNTY RESOLUTION

11 DESIGNATING THE CITY/COUNTY REGIONAL PLANNING AUTHORITY AS THE  
12 METROPOLITAN PLANNING ORGANIZATION'S TRANSPORTATION POLICY BOARD.

13  
14 WHEREAS, the City and County entered into a joint powers agreement in 1982 establishing a  
15 Metropolitan Planning Organization and Transportation Policy Board in accordance with federal  
16 regulations for the purpose of developing a transportation plan and programming of federal and state  
17 funds for the implementation of that transportation plan; and

18 WHEREAS, the City and County created a joint powers agreement in 2000 establishing a  
19 Regional Planning Authority for the purpose of preparing land use and transportation plans for a  
20 greater Santa Fe region; and

21 WHEREAS, the Transportation Policy Board membership consists of the Mayor of the City of  
22 Santa Fe, three city councilors and three county commissioners and the Regional Planning Authority  
23 membership consists of the Mayor, three city councilors and four county commissioners; and

24 WHEREAS, comprehensive regional planning and the citizens affected by that planning will  
25 be better served by combing these two boards into one authority.

1 NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE  
2 CITY OF SANTA FE AND THE BOARD OF COUNTY COMMISSIONERS OF SANTA FE  
3 COUNTY that the Santa Fe City/County Regional Planning Authority is hereby designated as the  
4 Santa Fe Metropolitan Planning Organization's Transportation Policy Board.

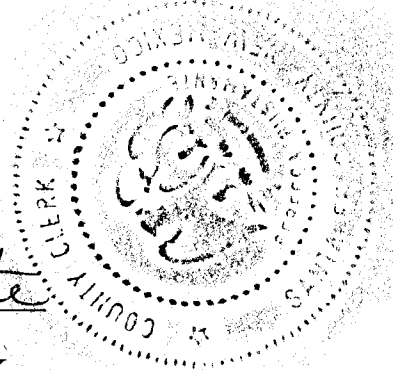
