Request is to transfer investment earnings realized on bond proceeds in Fiscal Year 2000 from the General Obligation Bond (Series 1999) -Open Space Fund (385) to the GO Debt Service Fund (401). This request corrects Resolution 2000-78.
- 2) Why was this request not included in the Fiscal Year 2000 Operating Budget?
The bond document requires investment earnings accumulated in the Bond Proceed Fund (Fund 385) to be transferred annually at the end of the fiscal year to the Debt Service Fund (401) and used to pay debt service.

This request is anticipated to be non-recurring for this fiscal year. It is anticipated that whatever investment income is earned in Fiscal Year 2001 will be transferred from the proceeds fund to the debt service fund at the end of the fiscal year.

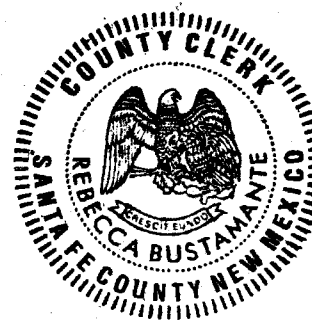
