A Resolution Amending Resolution 1999-131 Changing the Polling Place Location of Precinct 22

WHEREAS, Section 1-3-2 NMSA 1978 requires that the Board of County Commissioners designate the polling place of each precinct in Santa Fe County no later than the first Monday in November of each odd-numbered year; and

WHEREAS, Resolution 1999-131 designated the polling places for the Primary and General Elections to be held in 2000; and

WHEREAS, it is necessary to change the polling place location of Precinct 22 from the Carlos Gilbert Elementary School to the Sweeney Convention Center; and

WHEREAS, in accordance with 1-3-5 NMSA it will be necessary to get approval from the Santa Fe District Court to make this change.

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of the County of Santa Fe that the County Clerk is granted approval to change the polling place location for Precinct 22 in accordance with 1-3-5 NMSA.

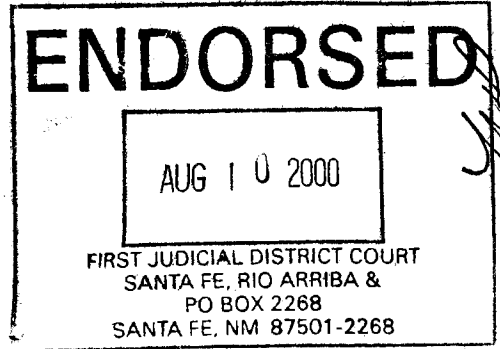
