SANTA FE COUNTY Resolution No. 2010-160

A RESOLUTION TO AUTHORIZE A LOW-INCOME and/or SENIOR CITIZEN CREDIT FOR RESIDENTIAL SOLID WASTE PERMITS PURSUANT TO SANTA FE COUNTY ORDINANCE NO. 2010-5, Section 13A(6).

WHEREAS, Santa Fe County Ordinance No. 2010-5, the County's Solid Waste Ordinance, provides that the Board of County Commissioners may authorize a low-income and/or senior citizen credit for Residential Solid Waste Permits; and

WHEREAS, Santa Fe County Ordinance No. 2010-5 raised the existing residential solid waste permit fees to \$65 for FY11, \$75 for FY 12, \$85 for FY 13, \$95 for FY 14, and \$105 for FY 15 & Thereafter; and

WHEREAS, the Board of County Commissioners does desire to authorize a low-income and/or senior citizen credit for Residential Solid Waste Permits; and

WHEREAS, Santa Fe County Ordinance No. 2010-5 further provides that, if such credits are authorized, the County Manager shall establish rules and procedures by which County residents may obtain such credits; and

WHEREAS, in order to provide for efficient and effective implementation of the rules and procedures used in the sale of permits, the County Manager should establish rules and procedures, not just for the low-income and senior citizen credit but for the complete process of the sale of Residential Solid Waste Permits;

NOW, THEREFORE, BE IT RESOLVED by the Board of County Commissioners of Santa Fe County, New Mexico, meeting in regular session, that:

1. Effective October 1, 2010, the Board of County Commissioners of Santa Fe County authorizes the establishment of a low- income and/or senior citizen credit for Residential Solid Waste Permits as follows:

- a. For low-income residents, a credit of Ten dollars (\$10.00) is authorized; and
- b. For senior residents (age 65 and older) a credit of Five dollars (\$5.00) is authorized.
- c. A resident meeting both qualifications shall only be eligible for the greater of the two credits.

2. Further, the Board of County Commissioners of Santa Fe County directs the County Manager to establish rules and procedures by which County residents may obtain such credits and the procedures to be used in Santa Fe County for the sale and implementation of the Residential Solid Waste Permit program.
