**A Resolution of Support for County Participation in the 2010-2011  
New Mexico Department of Transportation Local Government Road Fund  
Cooperative Agreement for Pavement Rehabilitation and Improvements of  
Santa Fe County Roads, to-wit: Verano Loop, Verano Court, Verano Lane,  
Verano Drive, Verano Place and Verano Way  
Under the Capital Cooperative Agreement Project No. SP-5-11(137)**

---

**WHEREAS**, pursuant to Section 67-3-28.2, NMSA 1978 as amended, assistance for local road construction and repair is available through the New Mexico Department of Transportation through the Local Government Fund; and

**WHEREAS**, the County of Santa Fe applied for funding from the Cooperative Agreement Program for pavement rehabilitation and improvements of County Roads, to-wit: Verano Loop, Verano Court, Verano Drive, Verano Lane, Verano Place and Verano Way in Santa Fe County, New Mexico (the "Project"); and

**WHEREAS**, the total project cost, including the twenty-five percent (25%) county participation, is \$88,447.00; and

**WHEREAS**, the County of Santa Fe has agreed, with the State of New Mexico, to utilize awarded funds from the Cooperative Agreement Program for pavement rehabilitation and improvements of Verano Loop, Verano Court, Verano Drive, Verano Lane, Verano Place and Verano Way, in Santa Fe County, New Mexico ; and


**WHEREAS**, in order to obtain funds from Local Government Road Fund, a local government must agree to provide matching funds pursuant to Section 67-3-32, NMSA 1978; and

**WHEREAS**, the Board of County Commissioners of Santa Fe County support the Project and agree to provide 25% of the funds for the Project, as required under the Cooperative Agreement Program.


**NOW THEREFORE, BE IT RESOLVED** that the Santa Fe County Board of County Commissioners agree to support the pavement rehabilitation and improvements of Verano Loop, Verano Court, Verano Drive, Verano Lane, Verano Place and Verano Way, in Santa Fe County, New Mexico, and will provide matching funds for this Project in the amount of \$22,112.00 under Project No. SP-5-11(137).


