A RESOLUTION CONFIRMING AND RATIFYING THE COUNTY MANAGER'S SIGNATURE APPROVING GRANT SAP 21-F2380-STB FOR THE SANTA FE COUNTY NM HWY 14 BULK WATER STATION EXPANSION, AND DESIGNATING AN OFFICIAL REPRESENTATIVE AND FISCAL OFFICER FOR SUCH GRANT

- 2. Katherine Miller, Santa Fe County Manager, is the official representative who is authorized to sign all other documents related to and necessary to fulfill the purposes Grant SAP 21-F2380-STB, including any amendments.
