**A RESOLUTION ACCEPTING SUBRECIPIENT AGREEMENT #21-ZF3512-2
AND SUBRECIPIENT AGREEMENT #22-ZG1018-6 FOR THE ESPANOLA
PATHWAY'S SHELTER RENOVATION PROJECT AND GRANTING THE
COUNTY MANAGER SIGNATORY AUTHORITY TO SIGN AND EXECUTE
ANY AND ALL DOCUMENTS RELATED TO THESE GRANT AWARDS**

WHEREAS, in 2021 the United States Department of the Treasury awarded funds via the Coronavirus Local Fiscal Recovery Fund (CSLFRF) to government agencies throughout the United States, including the State of New Mexico; and

WHEREAS, the State of New Mexico is allowed to subaward these funds to local governments; and

WHEREAS, the State of New Mexico, Department of Finance and Administration (DFA), wishes to award funds to plan, design, and construct project renovations and site improvements for Pathways Shelter including but not limited to electrical systems upgrades, upgrade of HVAC, plumbing upgrades, re-roofing, installation of fire suppression systems, sewer system repairs and site work; and

WHEREAS, DFA wishes to award funds to Santa Fe County via a Subrecipient Agreement for this purpose; and

WHEREAS, Agreement #21-ZF3512-2 in the amount of \$702,560.00 and Agreement #22-ZG1018-6 in the amount of \$97,440.00 were created for this purpose.

NOW, THEREFORE, BE IT RESOLVED, for the reasons stated above the Santa Fe County Board of County Commissioners accepts **Subrecipient Agreement #21-ZF3512-2 and Subrecipient Agreement #22-ZG1018-6** and authorizes the County Manager to sign and execute any and all documents related to these Grant awards.


