**A RESOLUTION AUTHORIZING THE DISPOSITION OF FIXED ASSETS WORTH \$5,000  
OR LESS IN ACCORDANCE WITH STATE STATUTE**

---

**WHEREAS**, Santa Fe County (County) desires to dispose certain tangible personal property identified in Exhibit A; and

**WHEREAS**, Exhibit A details items of personal property by department or office, tag number, description of fixed asset, vehicle identification number or serial number, reason for surplus, condition of fixed asset, location of fixed asset, and estimated value; and

**WHEREAS**, NMSA 1978, Section 13-6-1 governs the disposition of tangible personal property belonging to a local public body that is (1) of a current resale value of five thousand dollars (\$5,000) or less; and (2) worn out, unusable or obsolete to the extent that the item is no longer economical or safe for continued use by the body; and

**WHEREAS**, the Board of County Commissioners (“Board”) hereby determines that all items of tangible personal property on Exhibit A with estimated values of five thousand dollars (\$5,000) or less are (i) worn-out, unusable, or obsolete to the extent that the item is no longer economical or safe for continued use by the County, and (ii) each has an estimated current resale value of five thousand dollars (\$5,000) or less.

**NOW, THEREFORE, BE IT RESOLVED** by the Board as follows:

1. The Board approves of the disposal of the personal property listed on Exhibit A with estimated values of five thousand dollars (\$5,000) or less in accordance with NMSA 1978, Section 13-6-1.
2. The Board directs that, to the extent feasible, the personal property shall be sold at public auction and, if that it is not feasible, that it be disposed of as otherwise allowed by law.
