WHEREAS, the County desires to donate said item of personal property listed on Exhibit A to Newkirk Fire Department in Guadalupe County, New Mexico; and



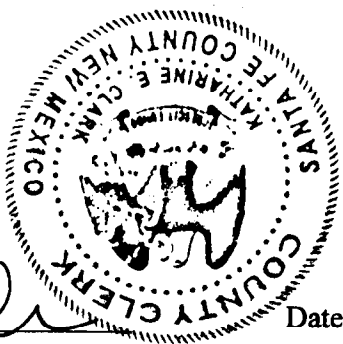
NOW, THEREFORE, BE IT RESOLVED by the Santa Fe County Board of County Commissioners that:




