1	<p>Please summarize the request and its purpose in the area below.</p> <p>The Santa Fe County DWI Program applies annually for the Community DWI Program (CDWI) funding from the New Mexico Department of Transportation. Funding for the CDWI project comes from a \$75 fee imposed on convicted drunk drivers, as allowed by NMSA 1978 Section 31-12-7(B) and regulation 18.20.6 NMAC (2004). The CDWI grant provides funds to cities or counties for alcohol-related prevention, enforcement, public information/education and offender projects. This funding allows for the DWI Program to purchase the needed equipment to assist in supporting in DWI operations across the County.</p> <p>Santa Fe County received Grant #05-CD-05-091 in the amount of \$2,671.
