RESOLUTION NO. 2024 - 128

A RESOLUTION RESCINDING RESOLUTION NO. 2024-90, GRANTING THE COUNTY MANAGER AUTHORITY TO NEGOTIATE AND EXECUTE A LEASE OF THE BENNIE J. CHAVEZ SENIOR CENTER ON BEHALF OF SANTA FE COUNTY WITH THE UNITED STATES POSTAL SERVICE TO PROVIDE A LOCATION FOR A POST OFFICE FOR THE RESIDENTS OF CHIMAYO AND NORTHERN SANTA FE COUNTY

WHEREAS, Santa Fe County approved resolution 2024-90 on July 9, 2024, granting the County Manager the authority to negotiate and execute a lease of the Bennie J. Chavez Senior Center on Behalf of Santa Fe County with the United States Postal Service to provide a location for a Post Office for the residents of Chimayo and Northern Santa Fe County; and

WHEREAS, Santa Fe County recognizes the value the Bennie J. Chavez Senior Center holds to the Santa Fe County community; and

WHEREAS, the impacted community voiced strong opposition to placing a post office at the site of the Bennie J. Chavez Senior Center; and

WHEREAS, On September 24, 2024, during a regularly scheduled meeting of the Santa Fe County Board of County Commissioners (Board), the Board instructed staff to bring forward a resolution rescinding Resolution No. 2024-90.

NOW, THEREFORE, BE IT RESOLVED, by the Santa Fe County Board of County Commissioners that Resolution No. 2024-90 is hereby rescinded.




