RESOLUTION NO. 2024 - 129

A RESOLUTION TO REQUEST AN EXTENSION TO COMPLETE LOCAL GOVERNMENTS ROAD IMPROVEMENT FUND PROJECT NO. SB-L500551 FOR PAVEMENT REHABILITATION/IMPROVEMENTS OF VALLE VISTA BOULEVARD, LAS LOMAS DRIVE, SAN MATEO WAY, SIERRA PLACE, TUSA DRIVE, AND VAL VERDE DRIVE

WHEREAS, pursuant to NMSA 1978, Section 67-3-28.2 (Local governments road fund created; uses), assistance for local road construction and repair is available through the New Mexico Department of Transportation (NMDOT) from the Local Governments Road Improvements Fund (LGRF); and

WHEREAS, the County of Santa Fe (County) previously applied for fiscal year 2024 LGRF funding for pavement rehabilitation/improvements on various roads within the County; and

WHEREAS, by letter dated May 22, 2023, NMDOT informed the County that Project No. SB-L500551 (the Project) was approved; and

WHEREAS, prior to development of a Cooperative Agreement for the Project with NMDOT, the Santa Fe Board of County Commissioners (Board) adopted Resolution No. 2023-079 on July 25, 2023, (see Exhibit A) adopting the Project and verifying its priority status; and

WHEREAS, the completion of the Project was delayed due to staffing shortages in the Road Maintenance Section within the Public Works Department; and

WHEREAS, the County Public Works Department desires to officially request from NMDOT an extension of the December 31, 2024, deadline to December 31, 2025; and

WHEREAS, the location and other information concerning the Project is depicted on the attached map (see exhibit B) and in the following table:

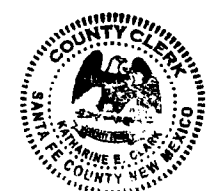

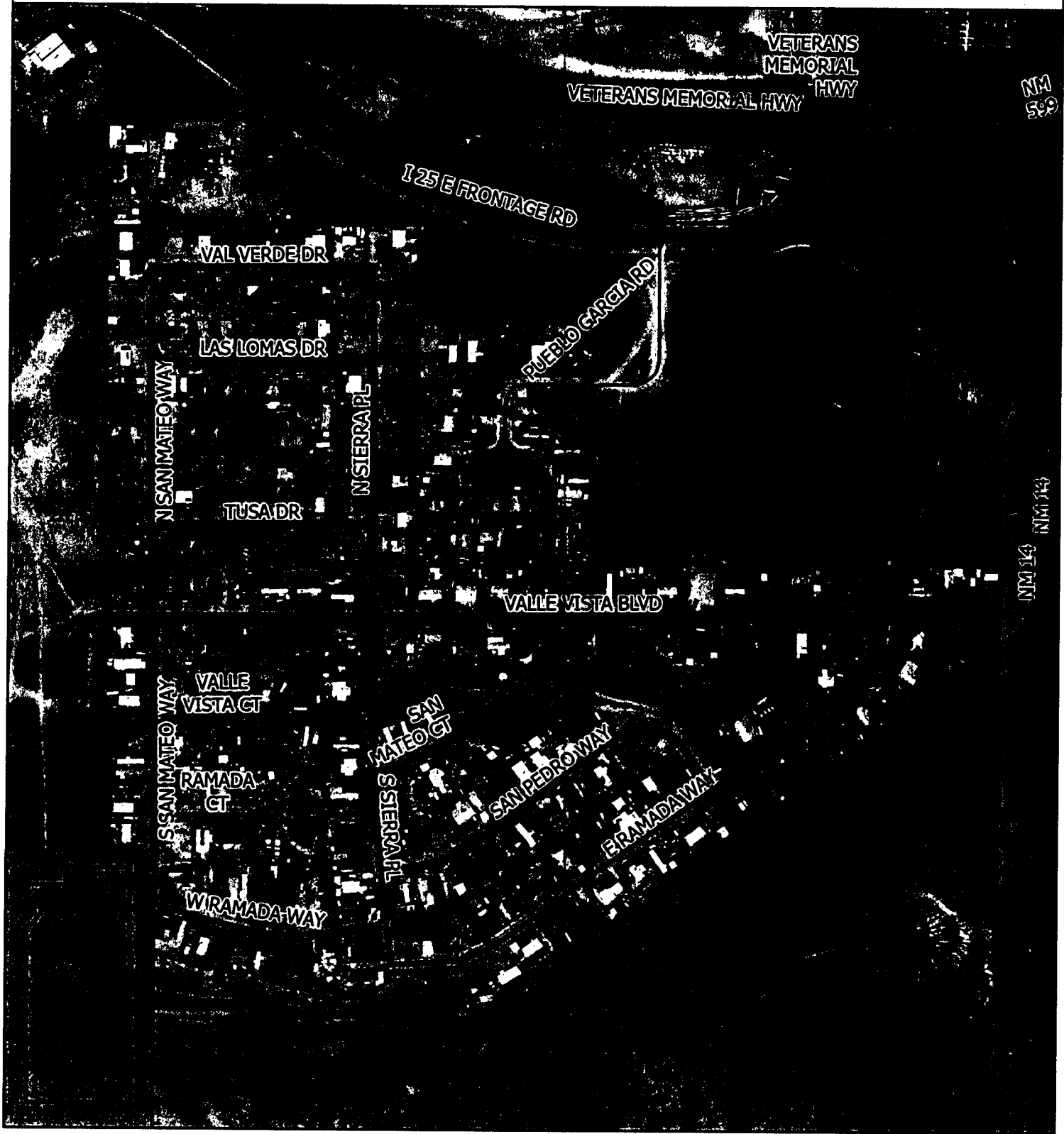

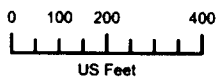
Santa Fe County Project Map
