Created by the Bulletproof Vest Partnership Grant Act of 1998, the Patrick Leahy Bulletproof Vest Partnership (BVP) Program, administered by the BJA, reimburses states, units of local government, and federally recognized Indian tribes for up to 50 percent of the cost of body armor vests purchased for law enforcement officers. The Sheriff's Office currently has available funds from the 2022 and 2023 awards that need to be expended. There is currently \$1,680 available from 2022 that is set to expire on November 29, 2024 and \$1,634 available from 2023 that is set to expire August 31, 2025.
