RESOLUTION NO. 2024 - 101

A RESOLUTION IDENTIFYING SANTA FE COUNTY 2025 LEGISLATIVE PRIORITIES RELATED TO PUBLIC HEALTH AND SOCIAL SERVICES

WHEREAS, the legislative pre-filing for the 2025 Regular Legislative Session will occur between January 2, 2025, through January 17, 2025; and

WHEREAS, the Santa Fe County (County) Board of County Commissioners (Board) discusses and approves support for legislative priorities as an important step in assuring the preservation and provision of exemplary services and policies; and

WHEREAS, it is important that the Board take action to maintain revenues, programs, and services at the current or higher level; and

WHEREAS, the Board would like to demonstrate strong support to the state legislature for legislation with respect to increased and/or enhanced public health and social services; and

WHEREAS, the Senior population continues to grow both nationally and at the local level, resulting in a much greater demand for essential services, such as food, nutrition, wellness, and transportation especially for Seniors who are home-bound; and

WHEREAS, the CONNECT program, implemented by Santa Fe County in 2018 in partnership with the City of Sant Fe and United Way, is a nationally recognized program that provide residents with the resources they need for health and wellbeing, including housing, food, transportation and utilities, often referred to as the social determinants of health; and

WHEREAS, Santa Fe County's Law Enforcement Assisted Diversion program, known as engage, which was initially funded through the State of New Mexico's Behavioral Health Services Division through a United States Department of Justice grant, and which has superlative relations with and the support of the Santa Fe County Sheriff's Office, the First Judicial District Attorney's Office, and the Office of the Public Defender, and has shown positive outcomes for individuals who come into contract with law enforcement and who have substance use and behavioral health issues; and

WHEREAS, New Mexicans are dying of alcohol-related harms at nearly three times the national average, and one in five deaths of working age New Mexicans is attributable to alcohol, and increased alcohol taxes have been shown to decrease drinking, including underage drinkers, as well as to decrease many alcohol-related harms.

NOW, THEREFORE, BE IT RESOLVED that the Board hereby supports the legislative priorities related to public health and social services as set forth above and specifically requests that the Legislature appropriate the following funding and enact the following legislation during its 2025 Regular session:



- 1. \$400,000 for Senior Services to help increase food security and nutrition, wellness outreach, and transportation services for Santa Fe County Seniors.
- 2. \$400,000 for the CONNECT program to be used as flexible funds to contract with providers within the CONNECT network to assist underserved residents with essential resources, such as food, clothing, shelter, and other social determinants of health.
- 3. \$400,000 for engage, Santa Fe County's Law Enforcement Assisted Diversion Program, to continue to provide long-term, intensive mobile case management to people with substance use and/or mental health challenges who are also justice-involved.
- 4. \$250,000 for the County's costs in participating in the Assisted Outpatient
 Treatment (AOT) pilot program in partnership with the First Judicial District Court
 and Administrative Office of the Courts.
- 5. Support the initiative to increase the Alcohol Excise Tax in New Mexico to help reduce alcohol-related harms while providing funding for more prevention efforts.
