Answer No. 1:	Staff may interview planners from adjacent counties, but they are not a priority stakeholder. More focus will be toward Pueblos, federal & state land management agencies, neighborhood & community organizations. The primary audience for engagement is the underserved communities and populations. We will engage regional organizations such as the Metropolitan Planning Organization, acequia associations, soil & water conservation districts and other stakeholders that have a direct interest in land use planning. We will prioritize stakeholders in the early steps, including recommendations from the Board of County Commissioner members as we expect to use a snow-ball method to identify unrepresented stakeholders.

Answer No. 2:	Yes, \$125,000 is reserved for Phase 1. One of the deliverables for Phase 1 is a cost estimate for the events to be implemented in Phase 2.
