The system will also encompass thorough correlation tests across all metadata, dynamic detection of mathematical anomalies, and an interactive dashboard app that provides real-time insights into the integrity and accuracy of election data.

The Clerk's Office has indicated that there are no other vendors that can provide the continued license and support of the system. By all technical terms, the purchase of license, maintenance and support can only be obtained from Civera, LLC.
