## **Connecting landowners with farmers and ranchers seeking land**

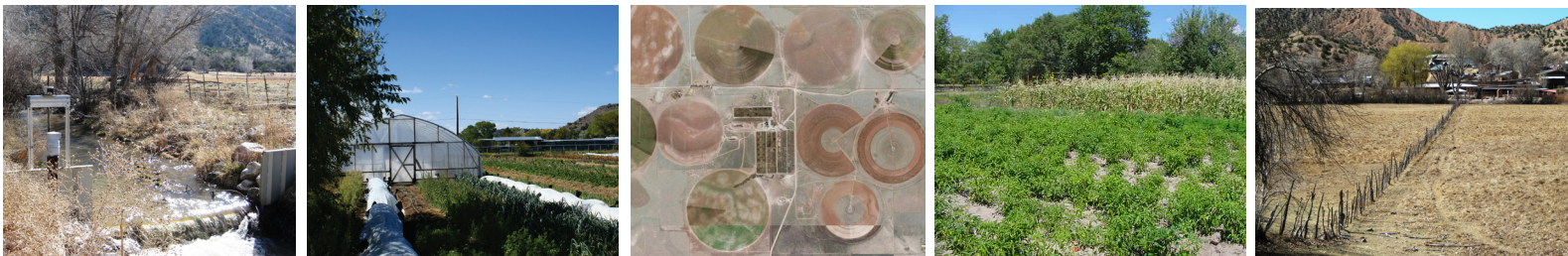

## **Collecting knowledge of agricultural resources in Santa Fe County**

The Agricultural Resource Inventory will establish baseline data regarding the current status of agriculture and ranching in Santa Fe County which will be available to community members, policy makers, business owners, researchers, and agricultural producers for the purposes of building resiliency and networks in the local foodshed.

## **Supporting the local food economy**

Santa Fe County will be conducting a local food system analysis to identify economic trends and opportunities in agriculture to enhance the local food supply and demand chain.
