June 6, 2002 & June 12, 2002

Chair Paul Duran in the Commission Chambers called a special meeting of the Santa Fe Board of County Commissioners to order at 4:35 p.m.

Roll Call was taken and indicated the presence of a quorum as follows:

County Clerk Rebecca Bustamante requested Commission approval to begin the canvassing of the June 4, 2002 Primary Election. She reported that it had been a smooth election. She handed out a copy of the unofficial results that were posted on election night.

Commissioner Gonzales moved that the County Clerk's request to begin the canvassing in accordance with the Election Code be approved and that the Commission stand in recess until said canvassing is completed.

Commissioner Duran seconded the motion.

The motion as presented was unanimously approved.

RECESS

With no further business to come before the Commission, Chair Duran declared the Commission in recess until completion of the canvass. The time was 4:44 p.m.

RECONVENED

The Commission reconvened on Wednesday, June 12, 2002 at 1:30 p.m. to certify the results of the Primary Election. A quorum was present. The record showed that the makeup of the members present was not the same as those that convened the meeting.

County Clerk Bustamante presented the results of the canvass and requested that the Commission certify the results. For some reason, some of the results were incorrectly given to her on election night. During the canvassing the mistake was caught. Commissioner Sullivan couldn't understand her explanation and asked for clarification. She explained it to him.

Commissioner Trujillo made the motion to approve the results of the Primary Election as stated by the County Clerk and that they be certified by the Commission and that said results be attached to these minutes as part of the record.(attached)


Commissioner Duran seconded the motion. Motion unanimously approved. Commissioners signed the canvass results.


ADJOURNMENT

With no more business to come before the Commission, the meeting was adjourned.


