Chair Paul Duran in the Commission Chambers called a special meeting of the Santa Fe Board of County Commissioners to order at 12:20 p.m.

Roll Call was taken and indicated the presence of a quorum as follows:

Chair Duran called upon the Honorable Phil Trujillo, Santa Fe County Treasurer.

County Treasurer Trujillo thanked the Commission for allowing him to put together a presentation on behalf of many individuals in Santa Fe County who were offended with the California Court's recent decision on the words **Under God** in our Pledge of Allegiance being unconstitutional. He proceeded to ask several members in the audience to go to the front of the room. A few examples of those he asked included a lady who represented the senior citizens; a city councilor; a county employee; the fire department; the police department and many more. Treasurer Trujillo then recited quotes from many leaders on the importance of the word **Under God**. He then asked everyone in the audience to join him in saying the Pledge of Allegiance to our Flag. Many in the community as well as many county employees attended the presentation. Councilor Robertson-Lopez speaking for Mayor Delgado and Chairman Paul Duran both indicated that the Pledge of Allegiance would always be said before their meetings.

Chairman Duran then asked for a motion to go into executive session to discuss the purchase of real property. A motion was made and seconded.

Clerk Bustamante called the roll on the motion. The motion was approved 3-0 with all members present voting yes.


The Board was in executive session until 1:40 p.m. Commissioner Gonzales participated in the meeting by telephone.

With no further business to come before the Board, the meeting was adjourned at 1:41 p.m.


