# La Cienega/La Cieneguilla Planning Committee Meeting 04

June 18<sup>th</sup>, 2024 La Cienega Community Center

# **Summary of Meeting**

## **Purpose of the Meeting:**

- Discuss the Revised Community Vision Statement
- Discuss Split Zoning and Tres Rios Ranch
- Discuss the Ordinance 2002-09 vs. SLDC Section 9.8 Comparison Matrix
- **Community Mapping Exercise**

#### Welcome:

The La Cienega/La Cieneguilla Planning Committee had their fourth meeting on Tuesday, June 18<sup>th</sup> at the La Cienega Community Center. Twelve community members attended along with County Planning Staff and facilitator, Rosemary Romero.

#### **Revised Communities Vision Statement:**

Staff presented a revised version of the Communities Vision Statement with revisions from one committee member. This will be the working Vision Statement, but there is ample time for further revisions. See the current Communities Vision Statement here.

#### **Split Zoning:**

At the request of a committee member who represents Tres Rios Ranch, we briefly discussed whether the committee still supports the rezoning of the Tres Rios Ranch to better preserve the property as they did in 2015. The Committee agreed with the rezoning and we discussed either including it in the Plan or pursuing a rezoning process separate from the planning process. We also briefly discussed the possibility of changing the various properties that are split zoned, but some committee members talked about the history of how they deliberately determined the zoning for those properties in past planning processes.

## Ordinance 2002-09 vs. SLDC Section 9.8 Comparison:

Staff presented a comparison matrix of the Ordinance 2002-09, the original La Cienega/La Cieneguilla zoning ordinance, versus the SLDC Section 9.8, the La Cienega/La Cieneguilla Community District Overlay, along with the SLDC as a whole. Overall, many regulations that were not carried into SLDC Section 9.8 are elsewhere in the SLDC. One significant omission are protections and setbacks for acequias. The Committee should consider whether they would like to include such regulations in the Plan and to be implemented in the Overlay. Refer to the Comparison Matrix <a href="here">here</a>. ## **Community Mapping Exercise:**

Finally, the committee spent the remaining 40 minutes with the community mapping exercise. At four separate tables, there were four topical maps including: littering/solid waste hotspots, rural commercial and business areas, agriculture, and environmental protection/resource protection/historic preservation. These maps are visioning exercises answering questions such as where should a future community center be located or where should agriculture be encouraged.
