2024 Primary Election

Order for Automatic Recount

WHEREAS, NMSA 1978, Section 1-14-24(A)(3) provides that an automatic recount of the vote is required when the canvass of returns for an election in certain offices indicates that the margin between the two candidates receiving the greatest number of votes for the office is less than one percent of the total votes cast for that office in that election or five or fewer votes between the two candidates receiving the greatest number of votes for that office;

WHEREAS, on Tuesday, June 25, 2024, the Office of the New Mexico Secretary of State notified the New Mexico State Canvassing Board that based upon the results of the June 4, 2024, Primary Election, an automatic recount is required for three county contests and one multicounty State Representative contest;

WHEREAS, the canvass of returns for the June 4, 2024 Primary Election, for New Mexico State Representative, District 43 (Libertarian), Between Chris Luchini and Phillip Michael Mach, resulted in a margin of 5 votes, which is within 5 votes of the total votes cast for that office in Los Alamos, Santa Fe, and Sandoval County, and therefore an automatic recount is required in that contest; and

WHEREAS, the canvass of returns for the June 4, 2024 Primary Election, for Valencia County Treasurer, (Republican), between Ronald D Saiz and Danielle Marie Trujillo, resulted in a margin of 0.72 percent, which is less than one percent of the total votes cast for that office in Valencia County, and therefore an automatic recount is required in that contest; and

WHEREAS, the canvass of returns for the June 4, 2024 Primary Election, for Guadalupe County Commissioner, District 3 (Democrat), between Albert E Campos Jr and Ernest Chavez, resulted in a margin of 0.71 percent, which is less than one percent of the total votes cast for that office in Guadalupe County, and therefore an automatic recount is required in that contest; and

WHEREAS, the canvass of returns for the June 4, 2024 Primary Election, for San Juan County Commissioner, District 3 (Republican), between Sandra L Lanier and Scott A Eckstein, resulted in a margin of 0.61 percent, which is less than one percent of the total votes cast for that office in San Juan County, and therefore an automatic recount is required in that contest; and

WHEREAS, on Tuesday, June 25, 2024, the Secretary of State, pursuant to NMSA 1978, Section 1-14-24(B), properly notified the New Mexico State Canvassing Board that, based upon the results of the June 4, 2024 Primary Election, an automatic recount is required for State Representative, District 43 (Libertarian), in Los Alamos, Santa Fe, and Sandoval County; Valencia County Treasurer, (Republican); Guadalupe County Commissioner, District 3 (Democrat); San Juan County Commissioner, District 3 (Republican);

NOW THEREFORE IT IS ORDERED THAT:

- A.** Pursuant to NMSA 1978, Section 1-14-24, an automatic recount shall be conducted for State Representative, District 43 (Libertarian), in Los Alamos, Santa Fe, and Sandoval County; Valencia County Treasurer, (Republican); Guadalupe County Commissioner, District 3 (Democrat); and San Juan County Commissioner, District 3 (Republican);
- B.** The recount for State Representative, District 43 (Libertarian), shall commence at 9:00 a.m. on Tuesday, July 9, 2024, in the affected counties as outlined herein:
- Los Alamos County Precincts 001, 002, 003, 004, 005, 006, 007, 008, 009, 010, 011, 012, 013, 014, 015, 016, 017, 018, 019, 020, 021, 022, and 023;
 - Sandoval County Precincts 007, 016, 017, 018, 051, 078, and 079;
 - Santa Fe County Precincts 012, 080, 093, 145, and 154;
- C.** The recount for Valencia County Treasurer, (Republican), shall commence at 9:00 a.m. on Tuesday, July 9, 2024, in the affected county as outlined herein:
- Valencia County Precincts 001, 002, 003, 004, 005, 006, 007, 008, 009, 010, 011, 012, 013, 014, 015, 016, 017, 018, 019, 020, 021, 022, 023, 024, 025, 026, 027, 028, 029, 030, 031, 032, 033, 034, 035, 036, 037, 038, 039, 040, 041, 042, 043, 044, 045, 046, 047, 048, 049, 050, 051, 052, 053, 054, 055, 056, 057, 058, 059, 060, 061, 062, 063, 064, 065, and 066;
- D.** The recount for Guadalupe County Commissioner, Guadalupe District 3 (Democrat), shall commence at 9:00 a.m. on Tuesday, July 9, 2024, in the affected county as outlined herein:
- Guadalupe County Precincts 001, 002, 003, 004, and 005;
- E.** The recount for San Juan County Commissioner, San Juan District 3 (Republican), shall commence at 9:00 a.m. on Tuesday, July 9, 2024, in the affected county as outlined herein:
- San Juan County Precincts 054, 060, 061, 062, 063, 064, 065, 066, 067, 068, 070, 072, 073, 074, 076, 078, 080, 081, and 082;
- F.** The New Mexico Secretary of State shall prescribe the conduct and procedures of the recount pursuant to NMSA 1978, Section 1-14-24(C).
