

The topography is rolling grasslands that is home to a herd of Antilope (approximately 50 animals). In addition there quail, badgers, and coyote on the property in addition to a variety of birds.

The property is used for cattle ranching and will be continue to be used for that puropse. There are scattered cultural resource sites throughput the property.




